

EXECUTIVE SUMMARY

Founded in 2015 Boğaziçi Ventures (BV) has been actively establishing funds that invest in technology or are managed with technology. Thanks to the talented and aspiring founders, the Turkish tech ecosystem keeps in a very promising state and strong inclination towards tech entrepreneurship from former senior executives of well-developed and conventional industry companies still continues. Parallel to this, focused investment verticals of BV continued their growth through the year 2022 however it being a challenging year in terms of local and global economical and political crisis. In 2022, in Türkiye, which is the 3rd country in the world that receives the most game investments, a total of 362 million USD has been invested in 23 game companies. BV was one of those investors. In 2022, there was a great decrease in global finance in the financial technology market compared to the previous year. There remained a record level of funding in Fintech compared to previous years and 89 million USD was invested in 34 companies. Retail Tech being one of the other growing verticals had a total of 12.8 million USD invested in 8 retail technology initiatives in 2022. Compared to 2021, edtech startup investments decreased by more than 50% where a total of 9.3 billion USD was invested in 1042 startups in educational technologies around the world. BV keeps edtech as one of the focused verticals and added a new startup company in its portfolio in 2022.



2022 being a challenging year in terms of local and global economy and shrinking investment market as well as the strategic and political crisis globally, was a year of growth for BV. Prioritizing investing in Turkish startups and providing maximum value for its investors investments, BV has grown not only in terms of its portfolio but also in the governed intangible assets. Operating as Türkiye's leading alternative asset management company, BV continued enlarging its operations, portfolio and team. Portfolio companies of BV has reached a number of 27 by the end of 2022. Operations of 5 portfolio companies invested by BV Global Fund have continued their operations throughout the year. Together with the new investments BV Growth Fund portfolio has reached to a number of 22 with its solely technology driven startups with disrupting ideas. While growing the portfolio, the company continued its impact investment for the Turkish technology entrepreneurship ecosystem. The growing team of BV empowered the companies' operations as well as the ecosystem all year long in 2022. Experienced team members of BV have performed volunteered training, mentorships and attended events to exchange knowledge and information with the future entrepreneurs of Turkiye.

Newly established portfolio management company, BV Portföy has started its operations and applied for its 4 different private equity funds together with BV. Besides traditional investment and investment management models, BV Portföy will be establishing disruptive innovation funds managed by know-how and technology. BV has continued its investments with the ongoing funds during the year as well as structuring new funds to start operations in 2023. Bv Growth, Bv Global, Bv Game & Esports venture capital funds, new Pre IPO funds, and coinvestment fund BV Synergy will all be active in 2023 together with the thematic mutual funds to be astablished together with Bv Portföy.

Boğaziçi Ventures values its stakeholders. All year long stakeholder meetups and continuous, transparent reports took place. The first social impact report is published in 2022 and the company will continue reporting on its impact sustainably.



1.2 BV PORTFÖY YÖNETİMİ A.Ş.

BV Portfoy Yönetimi A.Ş. (BV Portföy) obtained operating licence from Capital Markets Board of Turkey in July 2022. BVP is authorised to incorporate mutual funds, venture capital funds and offer general investment advice.

BV Portföy started its journey to become a prominent asset management company dedicated to technology-oriented investments. Based on the impeccable track record of the founders i.e., Boğaziçi Ventures, in gaming and technology related investments, BV Portföy will be offering equity funds and venture capital funds.

Technology equities are dominating the world economy since early 2000s. Developed and developing countries are investing more and more on technology sector to gain competitive advantage in production and service economies. Natural clear-cut effect of technology implementation in processes creates a medium and long-term positive cash flow on the companies. BV Portföy is equipped with resources to identify the potential of companies to enjoy technology investments and reflect to managed fund portfolios.

BV Portföy incorporated balanced and hedge umbrella funds. Under those umbrellas, a balanced gaming and technology fund and a technology focused hedge fund will be incorporated. Those will invest in Turkish and international gaming and technology stocks.

On the other hand, an algorithmic fund pursuing the arbitrage opportunities between spot and derivatives market will be incorporated.

BV Portföy designed an investment process on mutual fund management to pinpoint disruptive companies that will offer products and services growing exponentially in the next 5 to 10 years. The objective is to invest in companies at the right valuation and at the right time. It is believed this approach will provide greater benefit to investors rather than tracking well-known indices and mimicking their portfolios. Strategic and tactical portfolio management will dominate the management style of those funds. Balanced and hedge funds of BV Portföy will be steering to generate return in medium to long term investment horizon.

On the venture capital side, 10-year tenured venture capital fund is incorporated with a co-investment strategy. Fund will invest fintech, HR tech, SAAS and other technology related start-ups aiming to offer remarkable return on investment.

BV Portföy is managed by executives with vast experience in venture capital investments, asset management, advisory, valuation and development. BVP will be utilising the network of consultants and partners of Boğaziçi Ventures to enhance fund management and asset allocation processes.

Organized to differentiate from conventional approach to asset management, BV Portföy will continue to research and develop investment funds offering promising returns in medium to long term in technology focused vehicles.

--- 1.3 BV DİJİTAL

BV Dijital, which started its operations in 2019, was founded to guide and contribute to technological transformation in rapidly developing fields such as new internet infrastructure Web 3.0, Metaverse, NFT, decentralized finance, and cryptocurrency markets. BV Crypto, which offered the first digital asset management service in Türkiye, has always carried out its activities by adopting the principle of maximum security-optimum allocation by following various trends in the market. In line with this, performing security controls, especially the sustainability of new technologies, and informing the investors in the most accurate way is one of the main duties and principles of BV Crypto.

BV Crypto, which fully complies with the guidelines and regulations on crypto asset service providers published by official institutions and organizations, particularly the Financial Crimes Investigation Board (MASAK) in Türkiye, and closely follows the developments in this field, sets an example in its field as it offers the first and only digital asset management service in our country.

These days, when the infrastructure of a decentralized internet has been created, a new trend emerges almost every year. BV Crypto, which has offered various digital asset baskets for the altcoin market and products that particularly focus on BTC in previous years, adapted to the new trends in the industry and introduced two new digital asset baskets, Metaverse-NFT Gaming and Masternode, to its investors in 2022. The Metaverse-NFT Gaming basket has become a new alternative created by Bogazici Ventures' expertise in the field of gaming, for games based with NFT products and using blockchain infrastructure. BV Crypto, which offers the opportunity to become an early investor in promising game projects, has revealed its long-term vision in the game industry thanks to this basket. On the other hand, the Masternode basket was implemented with the transition of Ethereum, the most advanced decentralized network, to the PoS infrastructure. BV Crypto demonstrated a strong example of its approach to adding value to the industry by allowing investors to take part in the security and decentralization of the Ethereum network without requiring to have complex technical knowledge.

In 2022, investments and liquidity have been extremely low due to the global inflation caused by the coronavirus and the Russia-Ukraine War. Cryptocurrency markets have also been experiencing challenges, perhaps of historical significance, due to being affected by the low liquidity problem. The continuation of BV Crypto's activities during this challenging period has been a result of the maximum security and optimum allocation principle, and the management principle based on long-term goals has also proven the resilience and manageability of BV Crypto's products in such times.

FUNDS

Boğaziçi Ventures runs 3 funds all focusing on technology.

BV Growth - BV Global - BV Game & Espor

Details about the funds will be presented within this section however a brief intro to all is given below.

The first established fund of BV is BV Global. It is a friends & family fund established in 2015. There are investments from seed stage to Series A with a global focus. Mainly focused on fintech, retail tech, esports & gaming tech, health tech.

BV Growth is a venture capital investment fund subject to cubic meter (CMB) of TR. The fund has exceeded 400M TRY target fund size with 144 local and global investors. Investments have been made to; Seed & Pre-Series A, Türkiye-based, mostly disruptive technology startups in gaming, digital health, fintech, retail tech, edutech, hr tech and Web3 technologies.

BV Digital Asset Management established in Türkiye in 2019 is the leader and the only corporate entity which offers digital asset custody and allocation management services. It provides not only custodian service but also offers digital asset bundles planned in accordance with the possible scenarios and the developments in the digital asset markets from stable coins and DeFi markets to NFT and gaming products. Further more it produces and shares contents related to the digital asset environment.

2.2. BV GROWTH FUND

BV Growth Fund is a venture capital fund that supports Turkish startups at an early-growth stage as they take their global success to the next level while creating lasting value in the technology ecosystem established to provide high-level financial returns to its investors. Based in Turkey, BV Growth Fund has reached the target fund size of 400M TRY and will continue to accept investors until the end of 2023. The Fund has the approval of the Turkish Security and Exchange Commission on 9th February 2018. BV Growth invests in startups having talented teams, proven business models, the potential to scale up to a large number of users in international markets, and a need for financial support for their exponential growth in the future. The fund focuses on mainly gaming, fintech, retail tech, digital health, hr tech, edutech, Saas, and software businesses. Under retail tech, there are instore optimization, face & image recognition, ad optimization, segmented and personalized targeting, e-commerce management solutions, Al-based personalization, mobile app optimization, new media, and cyber security industries.

BV Growth fund has 144 investors and the fund's main investor is the Ministry of Treasury and Finance of Turkey, also there are corporate companies, portfolio management companies, pension funds, and other individual investors among the investors of the fund.

Strong inclination towards tech entrepreneurship from former senior executives of well-developed and conventional industry companies still continued in 2022. The Turkish tech ecosystem will remain as one of the most promising domains in the upcoming years due to the competitive labor force & skilled talent, strong entrepreneurial community and government support & incentives for the ecosystem. Market outlook on our targeted focus investment verticals are presented briefly within this section.


3.1 GAMING

Türkiye is thought to have more than 42 million players and a digital game market volume of over 1.2 billion USD in 2022, and approximately 78% of adult individuals play mobile games. In 2022, in Türkiye, which is the 3rd country in the world that receives the most game investments, a total of 362 million USD has been invested in 23 game companies. During the year, 63 new game companies were established in Türkiye.

In 2022, the total number of people who play digital video games surpassed 42 million and digital gaming market size in Türkiye was more than 1.2 billion USD.

Türkiye became the 3rd placed country that had the most invested gaming companies in the World in 2022. There were 23 gaming companies which got 362 million USD by angel investors & VCs. Also, 63 new gaming companies were founded in Türkiye in 2022.





3.2 FINTECH

In 2022, there was a great decrease in global finance in the financial technology market compared to the previous year. 75 billion USD was invested in 3630 companies.


When we look at Türkiye, we saw a record level of funding compared to previous years. 89 million USD was invested in 34 companies.

IIn 2022, a total of 4.5 billion USD was invested in 372 startups around the world. The average investment amount per venture was recorded as 15 million USD.



3.4 DIGITAL HEALTH


n 2022, 4215 investment tours took place in the world and a total of 54.3B USD was invested. The average investment amount per venture was recorded as 12.8 M USD.

INVESTMENT OPPORTUNITIES & NEW FUNDS ON MOVE

Last two years have been a global experiment of adaptation in many parts of our lives which highlighted the significance of technology startups. It is obvious that technology startups will continue to play key roles in the design of our social lifestyle as well as business operations.

Investments in venture capital promote entrepreneurship. By investing in early stage companies, we experience the needs of that business, while at the same time we experience how the future will be shaped. The venture capital investor finds out which new technologies and future-oriented industries with growth potential are currently emerging. Venture capital investments in early stages offer opportunities for high returns. In order to limit portfolio risk and still generate high returns, using a variety of venture capital strategies to spread risks is a common strategy.

Boğaziçi Ventures has already started performing on its future plans by new funds to be established. Details of the funds open to investment as well as new funds to be established are below:



4.1 BOĞAZİÇİ VENTURES GROWTH FUND

BV Growth fund is focusing on the most promising 6 verticals which are Gaming, FinTech, Retail Tech, HR Tech, Digital Health and Edtech where we see a huge opportunity for the Turkish tech companies to scale-up rapidly and expand to international markets. Currently, the Ministry of Treasury and Finance of Türkiye is a partner with BV in our active fund together with two universities, six retirement funds, twenty corporates, forty family offices and individuals.

Fundraising and investment process period of BV Growth continues at full speed in line with expectations and investment strategy. After a commitment of 270 million TRY at the first closing in December 2020, we aim to raise a total of 130 million TRY in the first quarter of the next year, to close the fund of 400 million TRY in total. In line with the fund's investment strategy and investment criteria, it is aimed to invest in a total of sixty ventures in the first four years. The fund will be open for investment in 2023.



4.2 BV SİNERJİ

By Sinerji is established to perform seed to series A investments to the well funded startups with reputable co-investors.

BV Sinerji performs technology investments with a multifocal model. The Fund invests in disruptive technology initiatives and creates strong ecosystem synergy, together with more than 100 domestic venture capital funds, strategic investment companies, holdings and investment banks, as well as foreign institutions that invest in more than 50 startups. BV Sinerji invests in all disruptive technology areas together with smart strategic investors especially where the Turkish ecosystem is strong: New Media, Gaming, EdTech, RetailTech, AgroTech. Thanks to the Fund's co-investment strategy, synergy investors diversify their portfolios through networks of private investors specialized in different fields. The fund structure allows investors to be a part of a large company which has a promising mid-term future and targets direct exit to strategic buyers or through IPO in 3-5 years.

Synergy investors create a regular income stream by receiving interim profit share without waiting for 8 years. Thanks to the larger funds that Sinerji invests together, they engage the increased capital and reduced risk factor. By Sinerji will be offered to investors by 2023 Q1.



4.3 PUBLIC EQUITY FUNDS

4.3.1 BV Portföy Game & Technology Fund

BV Portföy Game & technology Fund monitors closely the future of game trends, IP and technologies of the public game companies and invests accordingly. Boğaziçi Ventures has a proven track record and remarkable know-how in all verticals of the digital gaming industry. Bv Portföy fund managers monitors digital gaming recent trends, main pillars that will have disruptive effects on gaming market and following trend topics in the gaming discord channels dedicated to searching the next wining gaming company to invest in. Our fund will be offered for sale by 2023 Q1.



4.3.2 BV Portföy Technology & Innovation

Bv Portföy Technology & Innovation Fund will be established for investing into the tech companies which are expected to be super valuable with the future trends. Investing in international listed technology companies presenting potential for surpassing valuation in future.

Innovation evolving today is at the peak of the world history. Innovation is changing lives and businesses dramatically and it's creating opportunities to own the next big thing by investing to the correct entreprises today.

BV Portföy Technology & Innovation Fund invests solely in public companies which develop technology products and services to come up with disruptive innovation. The fund will be offered to investors by 2023 Q1.

4.3.3. Disruptive QUANT Funds

Boğaziçi Ventures together with BV Portföy will be offering disruptive Quant Funds purely managed by future engineering and technologies like machine learning and Al. High frequency trading using the top machine learning and artificial intelligence algorithms at the edge will be the core of those funds.

BV Portföy Quant funds aim to generate return over time-deposit rates as benchmark. Volume of algorithmic trading is increasing in equity markets. Well-developed and tested algorithms are able to generate positive returns on market movements and pair trading. BV AI Quant funds will be offered for investment by 2023 Q1/2.
